- Child Tax Credit with an annual household income (as assessed by Her Majesty's Revenue and Customs) that does not exceed £16,190
- Income Support
- Income Based Job Seekers Allowance
- Asylum Seeker
- Guaranteed Pension Credit
- Employment Support Allowance

***If you, or your partner is in receipt of Working Tax credit you are not entitled to Free School Meals even if your annual income is below the current threshold of £16190.***
